## TO LEAD

- **Convened first Beloved Community Summit** with 100 people in attendance. Presentations included information on Housing First for victims of domestic violence, evidence-based practices of survivor defined advocacy, and why putting the last girl at the center of our work is the right thing to do right now. We can't afford to wait.
- **Continued to expand our focus and attention** on issues of sexual violence, becoming a trusted source for media inquiries, technical assistance and trainings.
- **Participated in a group of Coalitions and National Organizations** focused on reinvigorating and strengthening the movement to end gender-based violence.

**Hosted a three day** statewide biennial conference with the Arizona Coalition for Victim Services titled, *"Domestic Violence, Sexual Assault and Victim Services: Three Movements, One Vision of Safety and Justice"* with support from Arizona Crime Victim Attorneys, Pima County Attorney Barbara LaWall, Aspire Business Consultants and APS.

- **271 attended**

- **45 workshops were facilitated** within five tracks on Domestic Violence, Sexual Violence, Victim Services, Prevention as well as Governance and Administration



**ACESDV went online** to reach a broader audience! **19 live webinars** were facilitated with **681 attendees** from Arizona and Nationally. **Webinars** presented on Domestic Violence 101 English and Spanish, Sexual Violence 101 English and Spanish, Advocacy and Empowerment, Reproductive Coercion and Birth Control Sabotage, Mandatory Reporting, Health and Emotional Effects of DV On Children, Safety Planning with Survivors, Trauma Informed Care, Advocating with the Littlest Victims: Promoting Resiliency in Children, Domestic Violence: Crime and Trauma, Dynamics of Domestic Violence and Why Victims Stay.

## TO PREVENT



Champions to End Violence Committee collaborated with the AZ National Guard, City of Phoenix, Arizona State University in putting together the 5K Walk/Run for Sexual Violence Awareness.



Coaching UP pilot program, with support from the NFL foundation and Arizona Foundation for Women, developed curriculum regarding positive leadership, healthy relationships and sexual violence prevention for student athletes.



Gender and Sexual Minority Committee developed training for Service Providers working with a victims and survivors from the GSM community and presented this training on the Maricopa Association of Governments Domestic Violence Council.



GSM Committee continues to work with City of Phoenix and assist in developing a LGBT domestic and sexual violence outreach brochure.



Developed the materials and curriculum for Prevention: Identifying Our Role in Stopping Violence Before it Starts training to be facilitated in upcoming fiscal year.

## TO END SEXUAL & DOMESTIC VIOLENCE



Early in 2014, domestic violence was in the national spotlight due to the release of the Ray Rice video. ACESDV was featured in many media stories locally about the issue, partnered with the Arizona Cardinals to hold the first ever Domestic Violence Awareness Game, and participated in events with the NFL around the Super Bowl and Owners' Meetings in Arizona.




